

## Expression of Interest - Supply of Diamond Aircraft DA40-NG

### 1. Introduction:

Australian International Aviation College, hereinafter referred to as the "Buyer," is seeking expressions of interest from qualified and reputable suppliers for the supply of aircraft. The scope of this project includes the procurement of two (2) Diamond DA40-NG Aircraft. The aircraft will need to have an Export C of A for export to Australia.

### 2. Specifications:

The aircraft should adhere to the following specifications:

- **Model:** Diamond DA40-NG (x2) with standard undercarriage ( approximate height of rear tie-down point is 550mm, may vary 10-50mm ) .
- **Year of Production:** Between 2016 and 2023
- **Total Time in Service:** Less than 3,000 hours
- **Avionics:** Garmin G1000 or G1000 NXi
- **Interior Condition:** Good condition
- **Exterior Condition:** Nil Damage history
- **Maintenance:** Up-to-date on all:
  - Applicable Manufacturer's scheduled maintenance and inspections (Aircraft and installed Components)
  - Country of Origin Airworthiness Directives (Aircraft and installed Components)
  - Manufacturer's Service Bulletins (Aircraft and installed Components)
- **Optional Equipment Required:**
  - DA40NG
  - Garmin GFC 700 Automatic Flight Control System
  - Active Traffic (Avidyne 6XX or Garmin GTS 800)
  - Garmin GTX 345R ADSB IN/OUT Mode S Transponder (preferred)

### 3. Delivery Timeframes / Location:

Two (2) DA40NG aircraft to be delivered in April 2024

Delivery to be made to Port Macquarie Airport NSW Australia

### 4. Eligibility Criteria:

Prospective suppliers must meet the following eligibility criteria to express their interest:

- **Legal:** The supplier must be a registered legal entity eligible to conduct business within the procurement jurisdiction.
- **Experience:** The supplier should have prior experience in supplying and dealing with Diamond aircraft.
- **Financial Stability:** The supplier must demonstrate financial stability and capability to fulfill the contract.
- **Compliance:** The supplier must comply with all applicable laws, regulations, and safety standards.

#### **4. Submission of Expression of Interest:**

Interested suppliers are requested to submit their expressions of interest in electronic format - secure file transfer (with the file password protected e.g. Dropbox). The file is to be transferred before the due date with the password to be sent at a later time as instructed. The file will include the following information:

Outline of the proposed aircraft, including specifications and compliance with the stated requirements

Applicability / Implementation of MSB-E4-039/3 and MSB-E4-042

Price

Delivery method and estimated cost (ferry flight or sea freight)
